

Sensity Deafblind and Sensory Support Network of Canada: Ceremonial First Pitch Nominee Application

The ceremonial first pitch is a tremendous opportunity to partner with the Toronto Blue Jays to raise awareness of deafblindness and Children's Intervenor Services during the month of June.

QUALIFICATIONS

- Nominee must be school aged and deafblind.
- Nominee must be accompanied on the field by his or her intervenor to highlight Children's Intervenor Services and the important work of intervenors. In years past, a parent has been permitted on the field with their child at the discretion of the Blue Jays. We will keep this option open, however the priority is to have the intervenor on the field.
- Nominee must be available for this year's game on **Wednesday, June 15, 2022**
- **Major League Baseball mandate requires : Proof of COVID-19 vaccination to participate in both pitch and attending game.**

EXPECTATIONS

- Families are expected to cover their own costs associated with the game including tickets, food, travel and accommodations. Sensity will pay for the tickets for the child and intervenor.
- Families must sign our photo consent form for all members in attendance at the game.
- To help better prepare your child, here is what you can expect on game day. In addition to any travel required to get to Toronto and the Rogers Centre, there is approximately a two- to three-hour commitment at the game. That time includes check-in, signing of waivers, possible media interviews, receiving a Blue Jays jersey, waiting at field level where Blue Jays mascot Ace meets and spends time with your child, and the ceremonial first pitch, photos and video.

NOMINATION PROCEDURE

- Completed nomination forms must be received no later than **Saturday, April 30, 2022.**
- All applications will be reviewed by a Sensity committee.
- The successful applicant will be contacted by **Friday, May 6, 2022.**
- If your child has previously thrown out the first pitch we ask that you do not apply to allow others the opportunity.

COMPLETING THE FORM

- Nominations for the First Pitch must be submitted using this nomination form.
- Digital versions of this nomination form will be accepted. This form is fillable but requires the latest version of Adobe Acrobat or Reader. Save the file and email it to the address listed below.
